2024 MAP Policy



The MAP for all Phone Skope products shall be no more than the MSRP provided in the Vendor Pricing Template.

The MAP policy applies to all advertisements of Phone Skope products in any and all media, including, but not limited to, flyers, posters, coupons, mailers, inserts, newspapers, magazines, catalogs, mail order catalogs, Internet or similar electronic media, television, radio, and public signage.

MAP does not establish maximum advertised prices. All dealers and sales representatives may offer Phone Skope products at any price in excess of the MAP.

Phone Skope's MAP policy does not in any way limit the ability of any dealer to advertise that "they have the lowest prices" or, they "will meet or beat any competitors price", that consumers should "call for a price" or phrases of similar import as long as the price advertised or listed for the products is not less than MAP.

Intentional or repeated failure to abide by this policy will result in termination of dealership or sales representatives. Phone Skope does not intend to do business with dealers or sales representatives who degrade the image of Phone Skope and its products. It is Phone Skope's sole discretion whether or not to provide prior notice or issue warnings before taking any action under this policy.

Negotiated Contracts: From time to time it may be explicitly approved by Phone Skope in writing to sell certain Phone Skope products at below MAP pricing. The discount amount and length of time will be determined at the time of this approved promotion by Phone Skope.

Sales representatives of Phone Skope products will supply a copy of the Phone Skope MAP policy to any new or existing reseller to be filled out, acknowledged and returned to Phone Skope. This form shall be signed and returned to Phone Skope and in doing so, will bind the reseller to abide by the MAP and reseller requirements spelled out in this document.

This MAP policy has been established by Phone Skope to help ensure the legacy of Phone Skope as a top producer of smartphone digiscoping adapters and accessories and to protect the reputation of its name and products. The MAP policy is also designed to ensure dealers and sales representatives have the incentive to invest resources into services for Phone Skope customers.
